Presented by	Felicia Flournoy – last year there was a review of the regional committees to see if they were effective and if members were happy with the results. The West, East, and Southwest members reported that they were happy with the way their committees were working and wanted to continue with regional committees. There was a discussion on eliminating duplications of efforts in the committees and staff will address this. The Mid-County committee, whose area was Banning/Beaumont and Hemet/San Jacinto, was placed on hold for reassessment and reconfiguration. What we discovered was Banning/Beaumont and Hemet/San Jacinto do not see themselves as one entity. They are very different and they have reservations on working together. We held several meetings to assess how the Pass Area felt about establishing a committee. A strategic planning session was held and there was a good turnout and positive response from the attendees. We then placed the onus back on the group to see if they could work together collectively to work on issues. The group wanted to create a steering committee and appointed one of the members to organize the next meeting. To date the meeting has not happened.

Informat	ion Item: Organization Critical Measures
	Discussion
Felicia Flournoy	Reminded members that they will receive an updated fiscal report at the April 18, WIB meeting. The fiscal report will be given out on a quarterly basis, along with program reports. Felicia explained that as a Continuous Quality Improvement (CQI) Organization we have a three prong approach to what we consider a high performance organization to be.
	 Our performance measures; that we must meet legislatively. These are our WIA outcomes. Critical Measures; what we look at to measure if we are headed in the correct direction. Strategic Outcome Measures; which are established by the Workforce Investment Board.
	We are continuously learning and re-evaluating our processes and how they work. Our Critical Measure scorecard goes beyond the measures WIA asks that we meet. We want to ensure our customers' satisfaction either increases or is sustained. Our goal is 100 percent customer satisfaction. We are an integrated site with the Employment Development Department (EDD) and we want to ensure that Unemployment Insurance (UI) customers are also being co-enrolled into our services.
	We also want to ensure that the number of training related job placements in our targeted industries increases. Right now the state does not track whether individuals who have completed our training programs received a training related job. We think this is very important and we want to internally and locally track this number. We consider this a critical measure. We want to ensure that not only are we training people in the right industries that are in demand but what happens when people complete the training.
	WIA does not track business services nor does it measure it. We want increase and monitor our business clientele to ensure they are receiving customer satisfaction. We want to make sure we are sending the right candidate with the correct qualification to businesses who seek our services to help cut their recruitment costs. This is a measurement we want to track. Then percentage of funds dedicated to services businesses increases. Because while legislation states we need to be servicing business, there is not a lot of emphasis on it. Business is one of our primary customers and we want to ensure that we are putting resources towards them. This will increase the strength of Riverside's small businesses.

Director's Report	
Felicia	For the upcoming fiscal year 2012/13 a continuing resolution was passed and we did not receive a cut funding so
Flournoy	we are level. Now the funding to go through the State formula for distribution to the counties. The RCOE education summit will be hosted in Palm Springs and Riverside. There are several bills being introduced for WIA reauthorization. Some of the language content continues to have Local WIBs, private sector mandatory and the One- Stop System. This is a positive thing because with consolidations of funding some of the money could be distributed towards workforce.
	The federal government released the Request for Proposal for Workforce Innovation Grants put out by the Department of Labor and we are having discussions to see if the grant should be done statewide or locally. We are looking to present a grant proposal for Southern California. We want to address young adults in transition and look at how we can design something around servicing them. This is population that is desperately in need but is underserved and has not been addressed. We will read through the application and I will talk with my counterparts in San Bernardino, San Diego, Long Beach and LA City and ask them to join us. This will be a joint project with the colleges involved. We are looking at an age group from $18 - 24$ or older. This group needs an approach that fits somewhere between youth and mature adults. Shelagh suggested using some of the rational arguments that were used to help achieve the Gates Grant. Shelagh will send information to board.
