# Discussion Francisca Hernandez – SlingShot is moving forward and the goal of the healthcare portion is to try to visit school sites that focus on healthcare training. Another challenge we are experiencing is finding employers for jobseekers once they are trained. Sharon Duffy – the Coachella Valley Economic Partners has found there is a need to reinvent school curricula that will focus on moving up education. Coachella Valley is a unique area, and finding curricula that fit its youth training needs is a challenge. Career Technical education is facing a shortage of teachers who are experts in the field to fill classes in the high schools. Laurie Stalnaker – WDB's Joint Labor apprenticeship coordinators will begin giving presentations so that people will begin to get a better understanding of apprenticeship programs and what we can offer. Sonia Nunez - the Logistics Roundtable is refining the training needs and once it is complete we'll create a list of high schools to visit and speak with students about Logistics and the career opportunities available. Jamil Dada – the Annual Workforce Holiday Meeting and Luncheon will be held at March Field Air Museum and Dr. Neal Schilling will be our keynote speaker.

October 29, 2105, is the next meeting.
