	Federal and State Report
Jamil Dada	The Workforce Innovation and Opportunity Act (WIOA) passed this summer and the Department of Labor Employment Training Agency is interpreting the law and writing the regulations. They are soliciting input from relevant individuals and agencies to help write the laws. The California Workforce Investment Board assigned a committee to look at WIOA implementation for California. The law will be completed and implementation will begin by July 1, 2015.
Imran Angelov Farooq	There will be a Green Collar Job Committee meeting in the next couple of weeks. Laurie Stalnaker asked if other state and federal committees were aware of the huge geographic area the Riverside, San Bernardino and the City of San Bernardino covers, which is 27,000 square miles. Jamil responded that historically it has been mentioned, but has little value in the overall importance of what the groups are trying to accomplish for everyone. But state and nation wide it is known that our region is one of the fastest growing and most dynamic areas in the country, especially in the next 10 to 15 years.

	Regional Committee Reports
West	Imran Angelov Farooq - Several community colleges partnered with Riverside County WIB to create an education consortium, which applied for the Trade Adjustment Assistance Community College and Career Training grant and was awarded a total of \$14,980,284 million to be distributed to the community colleges. The consortium will focus on the Advance Manufacturing industry and some of the funding can be used towards the Slingshot Initiative.
East	Juan De Lara – We had a successful Valley Wide Expo in September. We sold out; 71companies attended who had valid job openings. The training of our job candidates was much improved and the businesses noticed.The East Committee, along with Supervisor Benoit's office, is planning a Workforce Development Summit scheduled for November 13 th , 2014, at Fantasy Springs Resort to educate roughly 150 targeted businesses on Workforce Development and what the centers can offer them. This will be a free event for attendees and will last about 3 hours.
	 The East Committee members continue doing on-site presentations educating the public about the WIB. The latest presentations were done in Palm Springs, Cathedral City, Palm Desert, Indian Wells, and Coachella. These presentations are being set up, supported, and attended by committee members to educate the private sector on workforce development and how it can help them. Through Layne Arthur's member initiative, a WIA enrolled older worker customer was hired by the Nutritional Services Division of Palm Springs Unified School District. College of the Desert received \$165,000 in TAA funding to support an on campus staff person in the position of Placement Coordinator.
Southwest	The Southwest Committee continues to add members, but more private sector members are needed and we will focus on bringing them in now and at our Let's Do Business event in January 2015. The event is designed to

bring in businesses to educate them about the WIB, get them engaged and discuss their need through focus
groups. We need to get the private sector re-engaged and a subcommittee has been created to plan the event.

	Council for Youth Development Report
Maria	The CYD held its elections for the 2015 Chair and Vice Chair persons. The 2015 Chairperson is Charles
Muldrow	Fischer, Executive Director Riverside County Office on Education. The 2015 Vice Chairperson is Rosa
	Penaloza, Director, Arbor Youth Opportunity Center. Our Youth Opportunity Centers' provided a report on customer service satisfaction data aligned to their performance.
Jamil Dada	We took six youth from the YOCs to Washington D.C. in September to do youth advocacy presentations. We visited both Senators' offices and the youth spoke to their staff. They met with five members of Congress face-to-face. The members appreciated the briefings and the input it gives them when they go to vote, they are aware of the impact programs are making. The youth gave their testimonies; they were all high school drop outs who were able to turn their lives around thanks to the youth programs that have been provided.

Executive Director's Report	
Mark Christiansen	 Riverside County's unemployment rate for August 2014 was 9.2 percent and reflects a drop over the July rate. This time last year it was at 10.9 percent. The internal performance report of the Youth Opportunities Centers show that they are exceeding in all measures. Update on training currently, there are 287 individuals in training, with 65 pending, 888 youth enrolled in the 6 YOCs. The @LIKE program has enrolled 505 youth and continues to add to this number. On September 22, 2014, Workforce Development hosted a successful open house for the National Workforce
	Development Professionals Month. We held a Resource Fair for the public, there was a good turnout of job seekers. Senator Roth, Assembly Member Medina and other dignitaries attended the event.
	ADDITIONAL DISCUSSION ITEMS
Morris Myers	Elections will be held in December for the 2015 Chair and Vice Chair Person. Will staff be sending out the nomination letter? Response was yes. This year we will have staff confirm prior to the Full Board meeting elections if a member is willing to be placed on the ballot. This will be done by November 1.
Laurie Stalnaker	Our two counties are huge and legislative individuals should be supporting us more. We should make a better effort to get representatives in the WIB meetings so they can see and understand what we do on a day-to-day basis. We should be asking them at the end of any meetings we schedule to support us in our efforts. Members discussed the challenges that come up trying to get representatives to WIB meetings and how it is an on-going effort that everyone is working toward. Morris asked staff to work with Laurie to compile the numbers that she mentioned, and identify which representative the numbers align with. Then create a worksheet for members to keep with them in case they come in contact with individuals they can advocate too.
