Discussion	Rosa Penaloza informed the WIB that 15 youth from the 5 YOCs joint advocacy project "Voices for Youth" just completed an advocacy trip to Sacramento to speak to Senators: Dutton and Emmerson, Assemblymen Cook, Miller, Jefferies and Cedillo and advocate on youth concerns. Several of the legislators remembered our group from last year and said they find these trips to be a good learning experience for themselves. They encouraged the youth to come back next year.		
	Morris Myers chaperoned the youths in Sacramento and he was impressed by their awareness of the issues they face and how much preparation they put into their research and presentation. He hopes the group will continue to grow and that alumni will continue to comeback to mentor and help train the newcomers.

Discussion	Maria Muldrow and Thi Pham informed members that the Department of Labor awarded the Workforce Innovation Grant of \$6 million to the WIB. This collaboration was between Imperial, Riverside and San Bernardino Counties and focused on meeting the needs of youth between the ages of 21 to 26. This is a population is severely underserved because of their age, which is caught between the teen and adults years.			
	Riverside is the lead county and is in the process of holding strategy planning meetings. Thi explained the logic model, what it is and how it is used. The grant is for four years, 3 years for the process and one year of evaluation by an independent evaluator who will follow the process and report on its success. We hope to create lessons learned and a model that will be replicated for others to use in the future.

Information Item: 3.3 KVCR – The Dropout Rate and Its Impact on the Economy: Featuring Jamil Dada Discussion Jamil showed the Plugged Inland clips that featured his interview on how the dropout rate is impacting the economy.

Reports: Policy and Legislative Report Morris Myers - we held our second meeting and reviewed federal, state, and local information and decided which items to advocate. WIA funding is an important issue to but before our legislatures. We will be resending an survey to you that will help us with contacting legislators. **Council for Youth Development Report** Mary Jo Ramirez – the YOCs will be hosting open houses to invite legislators to the centers. The date for the open house will be sometime in October. Character Counts 2013 event is tentatively scheduled for April 26, 2013 We will begin taking nominees for the event later in the year. Chuck McDaniel, labor rep and CYD member reported that 325 people have been put to work on projects in the desert. It is possible another 100 people will be hired in Coachella Valley. On September 13, 2012, the unions will be taking applications for their apprenticeship programs and we will be connecting our youth with these opportunities. **Regional Reports** Lee Haven – the East Regional Committee is working to educate its political leaders in the desert area on the East importance of workforce development. The Department of Social Services workforce and EDD are meeting quarterly and will have report for our committee on their efforts at our next meeting. The East Regional committee members, businesses, educators and staff are participating in the development of a 5 year master plan for the eastern region to be recognized as a next generation learning community through the Coachella Valley

Economic Partnership(CVEP) in collaboration with the Workforce Excellence Oversight Committee.

Russell Best and John Arvil are spearheading an effort that will present information in a way that will help us organize our training data. We have some grassroots efforts going out in presenting workforce development to

Southwest

Morris Myers – our committee is continuing to grow. For the last 2 years we focused on healthcare and had 2 successful job fairs. We now want to focus on youth employment this year. One third of our funding goes towards youth and youth related projects. Our YOCs are there for the youth to support their efforts. We want to advocate for the WIB and workforce development by going out and getting on the agendas of our city councils to make presentations to them. We also want to present to school boards, water boards, chambers to let them know what is going on at the centers. We want everyone to know what we have to offer and to solicit their help to provide more services.

Chairman's Report

Jamil Dada – the new California Workforce Investment Board (CWIB) has been formed and the first meeting is set for early September. Twenty-three board members are new. At the National Governors' Association state chairs meeting the 15% set aside funding was discussed. Last year congress cut the governors' 15% set aside to 5% and gave the remaining 10% to the local boards. Jan Olsen the Assistant Secretary in the Department of Labor informed the chairs that an agreement has been reached to eventually return the entire 15% back to the governors. The Department has refused a request to abolish the local boards. The Workforce Investment Act will not be reauthorized this year but remains a priority in both houses, especially as they begin to understand it. The Democrats and Republicans have workforce bills and they are very similar. The main points are: boards will continue to be business lead, critical measures will be mandated and consolidation will happen. Possibly 550 local boards will become 450. There is a push to have workforce funding level for three years, instead of fluctuating from year-to-year. With level funding workforce can do a much better job of planning how to use its resources.
