There has been a significant increase of Workforce Services requested by businesses in Riverside County.


- Many WARN letters\* have been submitted from businesses furloughing employees.

## Business Engagement & Outreach





### Employers Requesting Recruiting Assistance by Industry




### Number of Individual Job Openings by Industry (openings WDC is helping to fill)

### # Of OJT Participants by Key Industry Sector













### Total Visits to Workforce Development Centers - June 2021




### Participants Receiving Career Services - June 2021




\* Career Services include assessments, individual employment plan, career counseling, and workforce preparation activities (e.g. resume writing, mock interviewing, and basic workplace skills).

### **Additional Opportunities**

- Homeless Veterans Grant-we currently have funds available to help veterans that are experiencing homelessness obtain employment. Funds can be used for transportation, housing, technology, or any other barrier that causes a hardship in obtaining employment.
- Community Career Coaching Grant-This grant pays a stipend to community members that help other community members that do not have access to the computer and internet build a resume and search for employment.
- Anthem Foundation Grant-RivCo works received a \$100,000 from the Anthem Foundation to provide workforces services within a community in Hemet that scored the lowest in the County on the Healthy Places Index Score. As part of the grant a community analysis and plan will be developed to determine the specific needs of the community and all 2,890 households within the community will be offered workforce development services.




# YOUTH OPPORTUNITY CENTER ACTIVITIES

## June 2021

The Workforce Development Center offers specialized services to youth age 16 through 24 at six Youth Opportunity Centers (YOCs) of Riverside County. YOCs are in Hemet, Indio, Lake Elsinore, Moreno Valley, Perris, and Rubidoux with services contracted out to Equus and California Family Life Center. Services begin with career exploration and guidance, ensure support for educational attainment and skills training, culminating with employment and/or enrollment in post-secondary education.



### DEFINITIONS

<b>In-School Youth</b>	An individual who is attending school; age 16 through 21 (unless an individual with a disability is attending school under State Law); with low-income; <u>and</u> one or more barriers identified by the Workforce Innovation Opportunity Act (WIOA).
<b>Out-of-School Youth</b>	An individual who is not attending any school; between age 16 through 24; <u>and</u> has one or more WIOA approved barriers.
<b>Youth Barriers</b>	The most prevalent barriers to employment experienced by youth include: Basic Literacy Skills Deficiency, Disability, English Language Learning, Foster Care, Legal Involvement, Homelessness, and Pregnancy or Parenting.

## **SUMMER TRAINING AND EMPLOYMENT PROGRAM (STEPS)**

The Summer Training and Employment Program for Students with Disabilities (STEPS) was applied for and granted to the Workforce Development Division in the amount of \$500,000 to serve 100 youth. The program will provide for work readiness and work experience for this demographic. Department of Rehabilitation (DOR) Grant amended the agreement to allot new funding and extend the term date to June 30, 2022.

- **Annual Report and Annual Newsletter Publications** An Annual Report is comprised by all five Youth Advisory Councils and is filed and presented to the Board of Supervisors. This year it was presented at the June 22<sup>nd</sup> Board Meeting along with a slideshow to recognize the five Commissioners from the current school year. The 2<sup>nd</sup> Annual Newsletter went out via county-wide email to all county employees and departments. The Newsletter is a great way to showcase all the projects, events, collaborations and work we did throughout the council year. There is also a section for us to recognize our commissioners from each District and showcase photos from various events.
  
- **Alumni Association and Planning for 2021-2022 School Year** The Youth Commission staff continues diligently working with plans for the newly established Alumni Association and ways of increasing engagement and support to Alumni.
  
- **2020-2021 End of Year Overview** The Youth Commission had a successful year with over 5,951 community service hours. The Youth Advisory Councils partnered with several organizations this year for projects and virtual workshops. These collaborations included:
  - DPSS Foster Youth Graduation Baskets,
  - RUHS Public Health's Teen Suicide Awareness and their Distracted Driving Programs,
  - United Way's Financial Literacy Academy,
  - Rainbow Pride Youth Alliance's Adverse Childhood Experiences Workshop,
  - and the Riverside Area Rape Crisis Center's workshop series.

These training sessions were able to educate our students and encouraged them to provide this information to the community via social media campaigns. The Youth Commission also participated in Riverside County's Masks are Medicine Campaign to encourage the community to stay at home, social distance, and stay safe during the pandemic.

The Youth Commission's annual events were held a little differently this year due to the pandemic. The Youth Commission successfully hosted the Annual Youth Retreat, Youth in Government Day and the 22<sup>nd</sup> annual Youth Summit virtually.

# AJCC Operator Activity Report

## July 2021

The primary role of America's Job Center of California (AJCC) Operator is to bring continuity among the AJCC partners to provide services to customers that utilize the AJCC resources throughout Riverside County. The AJCC Operator ensures the coordination of services between partnering agencies and customers. The goal is to ensure services offered are being provided to customers whether it be via job-readiness, career development, employment, and vocational training services.

### Promotion of AJCC/Outreach

Nonfarm employment up 9,600 over the month and 134,500 over the year**

The unemployment rate in the Riverside-San Bernardino-Ontario MSA was 7.2 percent in May 2021, down from a revised 7.5 percent in April 2021, and below the year-ago estimate of 14.9 percent. This compares with an unadjusted unemployment rate of 7.5 percent for California and 5.5 percent for the nation during the same period. The unemployment rate was 7.2 percent in Riverside County, and 7.3 percent in San Bernardino County.

**Between April 2021 and May 2021**, total nonfarm employment grew from 1,514,000 to 1,523,600, an increase of 9,600 jobs. Agricultural employment increased by 1,400 jobs.

- Leisure and hospitality (up 3,300) recorded the largest payroll increase over the month. Accommodation and food services (up 3,800) accounted for the entire job gain. Within accommodation and food services, food services and drinking places (up 3,000) recorded the largest employment increase, while accommodation added 800 jobs over the month. Arts, entertainment, and recreation cut payrolls by 500 jobs.
- The government sector (up 1,800) increased payrolls over the month, where local government (up 1,600) recorded most of the gain, while state and federal government each added 100 jobs.
- Additional employment gains were recorded in construction (up 1,600), manufacturing (up 1,300), trade, transportation, and utilities (up 700), other services (up 600), educational and health services (up 300) financial activities (up 300), and information (up 200).
- Professional and business services (down 500) recorded the only job loss over the month.


**Between May 2020 and May 2021**, total nonfarm employment increased by 134,500 (up 9.7 percent). Agricultural employment fell by 500 (down 3.2 percent).

- Trade, transportation, and utilities led the year over increase, adding 56,400 jobs. The upswing was noted in transportation, warehousing, and utilities (up 26,800), retail trade (up 26,000), and wholesale trade (up 3,600).
- Leisure and hospitality advanced payrolls by 30,900 jobs. Employment increases were reported in accommodation and food services (up 28,900), while arts, entertainment, and recreation added 2,000 jobs.
- Additional year-over employment gains occurred in the following sectors: educational and health services (up 18,500), professional and business services (up 13,300), construction (up 9,400), other services (up 4,900), government (up 800), financial activities (up 500), and information (up 300).
- Manufacturing (down 500) reported the only nonfarm job loss over the year.
