EXPANDED SUBSIDIZED EMPLOYMENT

One of the biggest perks of running your own business, is being able to give the opportunity for your employees to learn, grow, and advance in their careers.

This perk does not come without its own risks. Hiring and training employees can be an expensive endeavor. What if we told you that Riverside County has a program that can help with that risk?

The Expanded Subsidized Employment (ESE) program is designed to help connect job opportunities to a specific pool of candidates who are looking to find a pathway off of county benefits such as, Cal Fresh, Cal Works, and ultimately gain self-sufficiency.

Within this program the business will be able to be reimbursed up to 100% of the employee's wages for the first six months. After the first six months, eligible employers

can extend the contract for another six months at 25% wage reimbursement.

How it works:

1. Meet with a member of our workforce team to determine eligibility and begin the onboarding process
2. Notify your workforce team member of all full-time/part-time, entry-level positions you are looking to hire. (Must work 20hr/week minimum)
3. Receive a few resumés of potential candidates and go about your hiring process as normal
4. Once a month provide the appropriate documents for invoicing and your reimbursement check

It is a simple and great way to get the help you are looking for, and to lift members of your community to self-sufficiency.

Hiring Homeless Tax Credit (AB 150)

Beginning January 1, 2022 through December 31, 2026, employer may receive \$2,500 to \$10,000 in tax credits per employee. This is due to the Homeless Hiring Tax Credit (HHTC).

Credits will be based on actual hours worked in the taxable year per eligible employee. Employers can claim up to \$30,000 of credit per taxable year.

To be eligible, employees must be certified homeless by a certifying organization. Employers must make a tentative credit reservation online to claim the credit but will actually claim the credit when they file their taxes. A total of \$30 million of credit is available annually.

The HHTC Tentative Credit Reservation (TCR) must be done for any newly hired employees within 30 days of their date of hire and is also required to get the credit.

This will require a reservation for each eligible employee. You must submit your information online. You will receive an immediate confirmation.

In order to become an eligible employer, you will need to:

- Obtain an HHTC certificate for each eligible employee from a certifying organization.
- Pay wages equal to or greater than 120% of their California minimum wage.
- Make a tentative credit reservation within 30 days of hiring a new employee, or within 60 days of receiving a new certification for a previously certified employee.

Eligible individual employees must meet the following requirements:

- In the previous 180 days, be homeless or be receiving services from a homeless services provider, and
- Be certified by a certifying organization. The certificate expires 1 year after issuance.

An eligible individual may receive a new HHTC certificate if, they are homeless or have received supportive services from a homeless services provider, on the date the eligible individual receives a new HHTC certificate or anytime during the 180-day period immediately before that date.

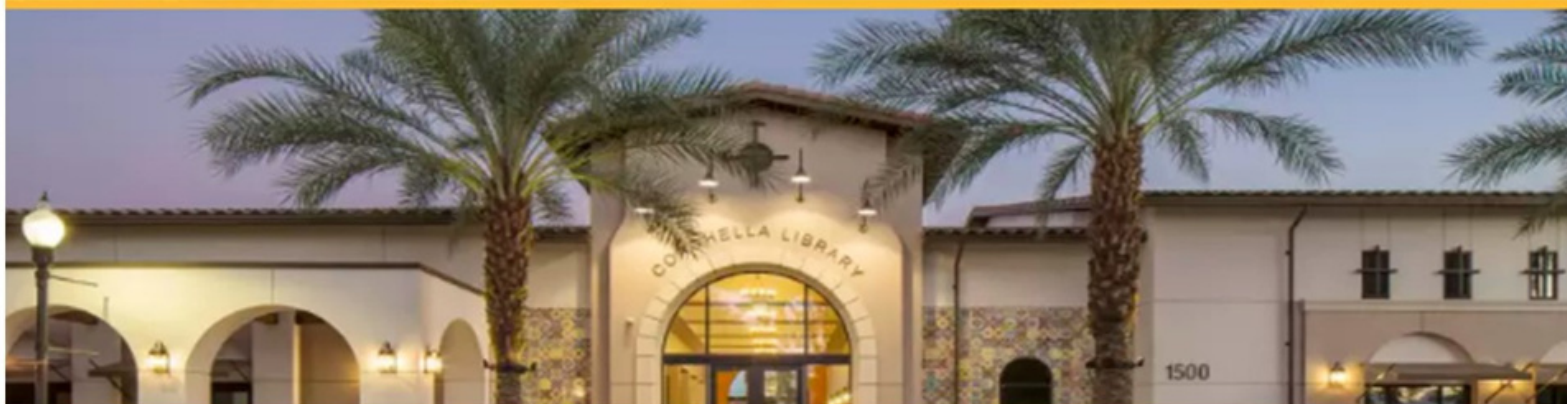

Hiring Homeless Tax Credit

Tax Credit between **\$2,500** and **\$10,000** per qualified homeless individual hired

AB 150 Includes:

Groundbreaking California Homeless Hiring Tax Credit that would simultaneously confront the homelessness crisis facing California, address the job losses stemming from the COVID-19 pandemic that have disproportionately harmed low-income communities, and ease the significant financial strain that many small businesses are currently experiencing.



To Qualify:

- Pay wages subject to withholding under the Unemployment Insurance code
- Pay family-supporting wages at or above 120% of minimum wage
- Employ the individual for at least 500 hours in that taxable year
