## ARTIFICIAL INTELLIGENCE & THE WORKPLACE

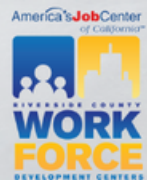

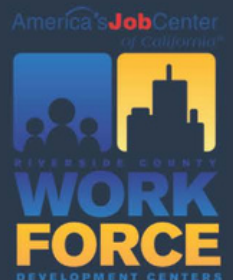
