Nonfarm employment down 32,300 over the month and up 23,700 over the year

The unemployment rate in the Riverside-San Bernardino-Ontario MSA was 5.5 percent in January 2024, up from a revised 5.0 percent in December 2023, and above the year-ago estimate of 4.4 percent. This compares with an unadjusted unemployment rate of 5.7 percent for California and 4.1 percent for the nation during the same period. The unemployment rate was 5.5 percent in Riverside County, and 5.4 percent in San Bernardino County.

<u>NOTE</u>: Labor Force and Industry data contained in this release differ from previous information due to the U.S. Department of Labor's annual revision process.

Between December 2023 and January 2024, total nonfarm employment decreased from 1,718,500 to 1,686,200, a decrease of 32,300 jobs. Agricultural employment declined by 500 jobs.

- All sectors declined over the month except for mining and logging which remained unchanged. Trade, transportation, and utilities lost the most jobs over the month losing 15,500 jobs. Fifty-three percent of job losses registered in retail trade (down 8,200). More specifically general merchandise retailers (down 2,600) and clothing, clothing accessories, shoe, and jewelry retailers (down 1,800) lost the most within retail trade. Transportation, warehousing, and utilities lost 7,200 jobs with all the decline reported in transportation and warehousing (down 7,300). Wholesale trade lost 100 jobs over the month completing the overall sectoral decline.
- Professional and business services declined by 6,500 jobs. Administrative and support and waste
 management and remediation services lost the most within the sector (down 5,500), followed by declines
 in professional, scientific, and technical services (down 900). Management of companies and enterprises
 lost 100 jobs completing the overall sectoral decline.
- Leisure and hospitality lost 3,700 jobs. Most of the job loss registered in accommodation and food services (down 3,200), followed by declines in arts, entertainment, and recreation (down 500).


Between January 2023 and January 2024, total nonfarm employment increased by 23,700, a 1.4 percent change. Agricultural employment increased by 200 jobs or 1.5 percent.

- Private education and health services added the most jobs over the year, expanding by 22,300 jobs. Ninety-two percent of the increase registered in health care and social assistance (up 20,600). Private educational services increased by 1,700 jobs completing the overall sectoral gain.
- Government increased by 12,400 jobs. Local government added 11,200 jobs, followed by gains in federal government (up 900), and state government (up 300).
- Trade, transportation, and utilities lost the most jobs over the month declining by 10,700. Transportation, warehousing, and utilities declined by 8,700 jobs, with all the decline registering in transportation and warehousing (down 9,000). Retail trade lost 1,200 jobs, followed by losses in wholesale trade (down 800).
- Leisure and hospitality declined by 3,800 jobs. Accommodation and food services declined by 2,900 jobs over the year. Arts, entertainment, and recreation lost 900 jobs.

The unemployment rate in the Riverside-San Bernardino-Ontario MSA was 5.5 percent in January 2024, up from a revised 5.0 percent in December 2023, and above the year-ago estimate of 4.4 percent. This compares with an unadjusted unemployment rate of 5.7 percent for California and 4.1 percent for the nation during the same period. The unemployment rate was 5.5 percent in Riverside County, and 5.4 percent in San Bernardino County.
